#### **Confirmed participation in E:IV**

#### Released: Technical manual for the execution of the E:IV survey in national settings

The manual reflects the experience of EUROSTUDENT network accumulated during the previous rounds of the project. It also takes into account the changes in core questions that have recently occurred as a result of the discussions within the working group and especially during December 2008 meeting in Vienna and January 2009 meeting in Sofia. It will assist participating countries to prepare for the start of national surveys. The manual is to be used for adapting the EUROSTUDENT IV core questions to the national environments. It follows the structure of EUROSTUDENT IV questionnaire and it is divided into



six sections. Each section starts with a short introduction that explains the topics covered. Each question is then given a special article organised in four units: Question; Explanation and Definition; Purpose and History. The manual was elaborated by the Bulgarian team of researchers under the EUROSTUDENT IV workpackage 2 Development of project conventions and definitions. The Center for Control and Assessment of Quality in Education (CCAQE) was given the task to assure that central conventions and definitions are established and are applicable to a maximum of cases in order to reflect the diversity of the social dimension of higher education in the participating countries. During the whole work process CCAQE and its research team received constant support by the Institute for Advanced Studies (IHS, Austria) and the Higher Education Information System (HIS, Germany). The technical manual can be downloaded from the project website and is available on the project wikipages for updates and national comments.

#### Appointed: 6 European experts for the International Steering Board

On 15 September the International Steering Board for EUROSTUDENT IV will convene in Berlin. The 6-member board encompasses experts from a wide spectrum of stakeholders and interested parties, who will help us clarify an appropriate strategy and development for the project. A member of the Steering Board is expected to stay in touch with developments in the area of higher education policy, especially the social dimension of European higher education and to remain up-to-date with developments within the EUROSTUDENT project. We will arrange three official meetings of the Steering Board, one at the start, one in the middle and one near the end of the project. Additional meetings may be called if they are deemed necessary. The table shows the six experts and the organisations and stakeholders they represent.

#### Intensive seminar "Planning and executing national online surveys for EUROSTU-DENT" on 16-18 September in Berlin

Following the success of our last intensive seminar in December (on the core questions for the EUROSTUDENT survey), we would now like to offer a further intensive seminar, this time on executing national online surveys. As we aim for an intensive exchange of expertise and experiences, we would like to restrict the number of registrations to 15. Further conditions for registration are: only one person per country, this person should be responsible for organising/executing an online survey for



EUROSTUDENT IV, and should be prepared to make an active contribution to the seminar. An invitation to participate was sent to all members of the EUROSTUDENT network on 25 June. Further information will be available shortly on the wikipages.



#### Researcher exchange programme

One of the continual aims of the coordinators of EUROSTUDENT is to encourage discussion and exchange of experiences between participating countries. To this aim, Martin Unger (IHS) has proposed a researcher exchange programme. This programme would offer researchers involved in EUROSTUDENT the opportunity to spend some time in a partner institution from the Network. This

would be a bilateral initiative between researchers interested in an exchange and institutions able to host a researcher for a period of time. We propose that the duration of the stay should be from a number of days to a number of weeks. For more information, please refer to the project wikipages.




### FEATURED INTERNATIONAL STATISTICS

Demographic change has become a subject of concern in European societies and elsewhere. The population is ageing through a combination of longer lives and less births. This development has particular relevance for the future development of higher education as the typical student age group is declining in many countries. The following two charts show, respectively, the typical age of a European student and a Eurostat prognosis for the development of this age group through 2020. The data substantiate the state of the Bologna Ministers in Leuven/Louvain-la-Neuve that, "(f)aced with the challenge of an ageing population, Europe can only succeed (...) if it maximises the talents and capacities of all its citizens and fully engages in lifelong learning, as well as in widening participation in higher education."


The data on the current age profile of European students shows that two-thirds are under the age of 25 and that 85% are under the age of 30 years old. The population prognosis shows that this typical student age group of 18 to 24 year olds will have decreased in size by 2020 by 12%, whilst the total population is expected to grow by 4%. Naturally, this picture of a reduction of students is more diverse on a country level (e.g. prognosis UK -7%, Germany -14% and Slovakia -33%). However, the conclusion must be that higher education systems look beyond the "normal" students in this age group. Countries which are more inclusive will ensure their sustainability and the fulfilment of skill requirements for a knowledge society.<sup>1</sup> This means evaluating the appropriateness of study conditions.

Recently for instance, a European wide survey of students found that 32% of all students

strongly agree with the statement that universities and colleges should provide more programmes for part-time students – and 39% of students over 25 years are of this opinion.<sup>2</sup> One of the tasks of EUROSTUDENT is, therefore, to describe these study conditions and help evaluate their appropriateness for sustainable higher education systems.
